- **Entry fee of \$10.00 per artwork** (up to 5 artworks per artist across all sections) payable in cash only at time of artwork delivery
- All Paintings must be wired and ready to hang and all paint must be dry, Photographs and drawings must be framed or mounted on card/board
- All artworks must be labelled with Title, Artist and Medium/s on the rear
- There are no size or weight restrictions on works, but if special handling or work exceeds 10kg, the Artist is required to provide help and/or moving/installation equipment. Please contact organisers if this is the case.
- Works may be for sale. Artists wishing to sell must label each piece with price and add artwork details to sales register at time of delivery. A commission of 10% of sales price will be deducted from all sales
- The event organisers reserve the right to refuse any entry and judges decisions are final
- While all care will be taken while handling and in the display of your artworks, the Lakeside Festival Committee and Tuncurry Memorial Hall Trust accept no responsibility for any loss or damage.

Section 1 – Stacks Law Firm Painting Prize

Section 2 – Drawing

Includes pencil, graphite, charcoal, digital drawing and any alternative mediums used for drawings etc. No size restrictions. Charcoal must be “fixed” or covered. No single sheets please, all works must be framed or mounted on card.

Section 3 –Photography

All photographic mediums allowed, Digital edits must not be more than 50% of the work

Section 4 - Junior Artist

This section includes all forms of art Photography & Design and is open to those **under 18 yrs – Entry is FREE but limited to 2 works per person.**
